In her first six months in San Diego, Jessica Hernandez, executive coach and founder of JLH Coaching and Consulting, has already discovered a wonderful community in Carmel Valley, a social and professional network in Lawyers Club, and a close-knit legal community in which she is excited to work.

After graduating from the University of Vermont and then George Washington Law School,

Certified as an executive coach, Hernandez helps attorneys in a variety of topics. "It really runs the gamut of things that can happen in the work space. Or, even beyond that, things that happen on a personal level."

Her recent move to San Diego has given her the opportunity to pursue a new career. She launched JLH Coaching and Consulting, which provides executive coaching and professional development consulting to individuals and organizations. Hernandez now works with individual attorneys in all environments on a broad range of issues, such as career transitions, effectively handling feedback, work/life matters, and business development. She also consults with organizations on professional development matters such as building effective feedback systems, diversity and women's initiatives, and programs to increase employee morale and productivity.

After moving to San Diego, Hernandez found another thing she loves – Lawyers Club. "I researched the market, came across Lawyers Club and was so impressed with it."
